
### AGREEMENT OPTIONS

- 10% of revenue to the White Buffalo Club










# **SPLIT AGREEMENT:**

### **HOUSE MANAGER PROGRAM:**

The House Manager is responsible for hiring out maintenance work for your property. All 3rd party vendors including maintenance are screened and approved by the White Buffalo Club management.
